Awards will be provided to three CTAI Members for a successful project or process that benefited their community or the state in the past year (September 2010 to August 2011).

Awards will be presented at the CTAI Fall Conference 2011, hosted in Sun Valley, Idaho on October 5-8, 2011.

Awardees will be:

- ◆ Recognized at CTAI's annual statewide coordination conference,
- ◆ Receive a plaque to highlight their achievement in their work location,
- ◆ Have a story featured on www.CTAI.org, and
- ◆ Recognized in the 2011 CTAI Annual Report.

Nominations will be accepted now through August 17th, 2011.

Awardees will be selected in August and announced at the Fall Conference.

Eligibility:

- ◆ Nominee must be a member of CTAI.
- ◆ Nominee must have participated in a project, process, or work with an organization that contributed to making a positive financial, health, or environmental impact for the benefit of their community or the entire state.
- ◆ Nominee must have actively participated in promoting the use of alternate forms of transportation.

Nomination process and selection details include:

- ◆ Anyone may nominate an individual, project, entity or process using the nomination form provided,
- ◆ Nominees will be evaluated to the extent they meet the criteria outlined on the nomination form.
